

-OFFICIAL RULES-

The Post Malone Experience Giveaway

1. SPONSORS

2. ELIGIBILITY

3. AGREEMENT TO OFFICIAL RULES

9. WINNER NOTIFICATION

Potential winners will be notified via phone and/or email using the contact information on their Forever True Account or on their mail-in entry form. The potential winner must respond within forty-eight (48) hours of notification and may be required to complete and return an Affidavit of Eligibility, Liability Waiver, and, where lawful, a Publicity Release, as well as provide proof of residency and any necessary tax forms. Failure to respond or comply within the 48 hours will result in disqualification and selection of an alternate winner.

The Sponsor is not responsible for any incorrect or invalid contact information, undeliverable messages, or technical issues that may prevent successful notification.

10. GENERAL CONDITIONS

11. RELEASE AND LIMITATIONS OF LIABILITY

Giveaway participants agree to release and hold harmless the Sponsor and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Giveaway, and each of their respective officers, directors, employees, shareholders, representatives, and agents ("Released Parties") from and against any claim or cause of action arising out of participation in the Giveaway or receipt and/or use of the Prize. This includes but is not limited to:

- a) Technical errors associated with the Giveaway, such as lost, interrupted, or unavailable Internet Service Provider (ISP) access, or network, server, wireless service provider, or related connection errors. Said technical errors may also include the unavailability, limited accessibility, or miscommunication of a failed computer, satellite, telephone, cellular tower, or cable transmission line, or a technical failure or jumbled, scrambled, delayed, or misdirected transmission or computer hardware or software malfunction, or failure;
- b) Unauthorized human intervention in the Giveaway;
